Caspian Horse Ownership Transfer Application

1. Please use one form per horse, this application must be *signed* and completed by the CHSA recorded owner of the horse at the time of sale. This form is for transfer of ownership on the records of the Caspian Horse Society of the Americas only and by itself is not proof of ownership. An executed Bill of Sale between the Buyer and Seller is recommended. This would be a separate private document and is recommended but not required by the CHSA.

2. Please note whether you want the Registration Certificate mailed to the Seller or Buyer after CHSA processing.

3. If the horse being transferred is a bred mare, please complete the Stallion Service Certificate, if not, leave this section blank.

4. Return the Transfer Application and the **original Certificate of Registration** with the transfer fee.

CHSA Member Fees: within 30 days \$15.00 • 31 to 90 days \$25.00 • after 90 days \$35.00 from date of sale.

Non Member Fees: within 30 days \$30.00 • 31 to 90 days \$50.00 • after 90 days \$70.00 from date of sale.
